#### Compulsory Registration

In all cases of RENEWAL documented by "appointments in the Police Station", it is possible to extend healthcare up to and including the date of appointment. In the event of renewal, healthcare will be extended for 1 year. The extension is documented by the "Renewal Receipt" (Police Station slip or Insured Mail) starting from the expiry date of the expired residence permit.</li> <li>In the event of renewals in excess of 12 months from date of the renewal receipt, healthcare is extended</li> </ul>

		<p>the application for regularisation or transformation of undeclared work into declared work</p> <p><b>Duration:</b> for six months renewable already from date of acceptance of the application recorded on the Receipt issued by the Portal.</p> <p>After 6 months from date of application, it must be ascertained whether the file for transformation of undeclared work into declared work is still pending: the interested party can document its pending status, alternatively, the One Stop Counter for Immigration (SUI) of the Prefecture can be directly involved. In the latter instances, an extension of 3 months renewable will be granted.</p>

If the length of detention is not indicated, registration will last for six months renewable.</p>

If under foster care, throughout the period of foster care. In the event of final adoption, the minor follows the right of the parents (whether foreign or Italian).</p>
