<ul style="list-style-type: none"> • Study purposes • Au pair placements <p>NB: it should be noted that people residing in Italy for study purposes and involved in au pair placements are entitled to voluntary registration even if present in the territory for a period of less than three months.</p>		<ul style="list-style-type: none"> • Residence permit or <u>declaration of presence for stays of less than three months</u> or receipt of first instance request or application for renewal of the residence permit; • Self-certification of having no income other than scholarships or subsidies issued by Italian public bodies (except for residents pursuant to au pair placements); if in possession of other income, the rule for the generality of assisted persons will apply (see above) • Certificate of voluntary contribution paid to postal account no. 289504 held in the name of the Tuscany Region • Statistical sheet referred to in Ministerial Decree of 08/10/1986; <p>Duration: the registration lasts for the entire calendar year, regardless of the registration date, as it is not divisible and has no retroactive effect.</p>
<p>On the registration fee, see Ministerial Decree of 08/10/1986:</p> <ul style="list-style-type: none"> • Voluntary registration entails payment of the annual flat-rate contribution proportional to the total income achieved in Italy and/or abroad in the year preceding that of registration, which sets the contributory percentage as 7.50% of total income up to € 20,658.27 per year; a contribution of 4% is due on the portion exceeding the aforementioned amount up to the limit of € 51.645,68. The amount of the contribution may not in any event dip below the sum of € 387.34. The contribution paid is also valid for family dependents. • For STUDENTS without income other than scholarships or subsidies issued by Italian public bodies, the amount is € 149.77. • For people on AU PAIR PLACEMENTS, the amount is € 219.49. <p>Registrations for students and people on au pair placements are not valid for any family dependents.</p>		

² The possibility of using self-certification for income received abroad is currently being discussed at ministerial level; despite the existence at present of divergent interpretations on its validity, the indication is to hold it admissible until the ruling by the competent national body and its subsequent notification
